Proposed Action Description:

Activities involving final deactivation and decommissioning (D&D) of multiple D-Area buildings. This revision incorporates the adding of demolishing building 463-55D (portable shed) and 681-24G (pump house structure). Additionally, the activity end date has been extended as part of this revision.
