Proposed Action Title: General Building Maintenance Activities in the SRTE Limited Area

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

This EEC covers various routine maintenance activities that occur in the Savannah River Tritium Enterprise (SRTE) Limited Area. This EEC covers routine maintenance activities and custodial services for SRTE buildings, structures, rights-of-way, infrastructures, during which operations may be suspended and resumed, provided that the activities would be conducted in a manner in accordance with applicable requirements.

This scope of work was previously evaluated under EEC NNSA-H-2023-00025. Since the EEC database no longer uses the previous business unit "NNSA," this revision was created to extend the activity end date.
