Proposed Action Title: Replacement of the Canyon Exhaust Fan #3 Motor

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Replacement of the CAEX Fan #3. Replace the existing fan, motor, pedestal and inlet vane damper with an equivalent model from the same manufacturer (or engineering approved equal). Also install backstop clutch on the fan shaft to prevent reverse rotation of the fan while it is not running. Fan and motor specifications shall match the current fan and motor. The size and load of the fan and motor will not change as part of this modification. The fan and motor arrangement shall not change. The existing handrail will be removed and replaced.
