Proposed Action Title: Wooden Asset Inspection of 115kV and 230kV Electricity Transmission Lines Maintained and Operated by Dominion Energy SC under Contract and Lease Agreements with DOE.

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Dominion Energy SC (DESC) leases DOE owned 115kV and 230kV electricity transmission assets. Further DESC maintains and operates the 115kV and 230kV electricity transmission system for DOE. DESC has hired Osmose Utilities Service Inc. to inspect the wooden assets, i.e., poles carrying transmission lines. This type of inspection is required every six years. In addition, to visual inspection of the above ground condition of the wooden assets, Osmose needs to inspect the condition of the assets below ground to confirm the structural integrity of the asset to support the transmission lines.
