Proposed Action Title: Building 263-241F Classified Storage Conversion

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Building 263-241F is currently an open storage facility originally constructed to support the Waste Solidification Building (WSB) storage requirements. To provide the storage capabilities needed for SRPPF production operations, 263-241F will need to be enclosed and attributes upgraded to be able to store materials with classified characteristics. These attributes include ASME NQA-1 Level B Storage, adding security features for the space to be a Vault Type Room (VTR), material receipt capabilities and forklift access without loading/unloading bays, upgraded lighting, and a new fire detection and suppression system.
