## **Floodplain Statement of Findings for the Floodplain and Wetland Assessment for the Installation of a Fiber Optic Cable from U.S. Forest Service-Savannah River Headquarters to the Advanced Tactical Training Area at the Savannah River Site**

This Floodplain Statement of Findings was prepared by the Department of Energy (DOE) in compliance with 10 CFR 1022. DOE prepared the Floodplain and Wetland Assessment for the Installation of a Fiber Optic Cable from U.S. Forest Service-Savannah River Headquarters to the Advanced Tactical Training Area at the Savannah River Site. The assessment concluded that the proposed action will not result in a loss of floodplain function or storage volume and will avoid wetland impacts. Available alternatives increased project costs by at least a factor of three with similar impact avoidance. The no-action alternative failed to support the project mission. The proposed action conforms to applicable floodplain and wetland protection standards.
