## Notice of Proposed Rulemaking for 10 CFR 830 – Nuclear Safety Management

The U.S. Department of Energy (DOE) Office of Environment, Health, Safety and Security has submitted a notice of proposed rulemaking (NOPR) to the Federal Register for 10 CFR part 830 – Nuclear Safety Management. This NOPR was issued by the Federal Register on August 8th, 2018 and is available at (<https://www.federalregister.gov/documents/2018/08/08/2018-16863/nuclear-safety-management>). The rule governs the conduct of DOE contractors, DOE personnel, and other persons conducting activities that affect, or may affect, the safety of DOE nuclear facilities. The proposed revisions reflect the experience gained in the implementation of the existing rule over the past seventeen years. The proposed revisions are intended to enhance operational efficiency while maintaining robust safety performance.

Public comment on this proposed rule will be accepted until October 9th, 2018. Public comment can be submitted in written form or by attending one of the public meetings.

4. **Aiken, SC at the University of South Carolina – Aiken, Business and Education Building, Room 124, 471 University Parkway, Aiken, SC, on September 27th, 2018.**

All public meetings will be held from 1:00 p.m. to 4:30 p.m. and from 6:00 p.m. to 8:30 p.m. local time. Interested persons who wish to speak at the public meeting should telephone the Office of Nuclear Safety, (301) 903-2996, by 4:30 p.m. Eastern time on August 13th, 2018 for Richland, WA, on August 31st, 2018 for Albuquerque, NM, on September 18th, 2018 for Oak Ridge, TN, and on September 20th, 2018 for Aiken, SC. Each presentation is limited to 20 minutes.
